A regular meeting of the Board of County Commissioners of Grand County, Utah, was held on Monday, July 18, 1977, at the hour of 10:00 a.m. at the Board's regular meeting place in Moab, Utah, at which meeting there were present the following members who constituted a quorum:

After the meeting had been duly called to order and the minutes of the preceding meeting read and approved, the following proceedings, among others, were duly had and taken:

The Clerk notified the Board of County Commissioners that the Notice of Intention to establish Grand County Special Service Water District, authorized by the resolution adopted by the Board of County Commissioners on the 20th day of June, 1977, had been published in the Times Independent,

a newspaper of general circulation in Grand County, Utah; said notice having been published three times, once during each week for three consecutive weeks, the first publication being not less than twenty-one (21) nor more than thirty-five (35) days before July 18, 1977, and that the affidavit of publishing said Notice of Intention with a copy of the notice as published was duly filed in his office, and a copy of said affidavit has been attached to these proceedings.

The Chairman and Board of County Commissioners then explained the purposes of creating the Special Service District and where the boundaries of said District were located, described the proposed improvements to be constructed therein, explained how the construction of said improvements is proposed to be financed, and answered questions submitted to them regarding said Special Service District by those in attendance.

The Clerk then presented a statement stating that

The Board of County Commissioners then considered each and every protest so filed, whether written or oral, and heard each and every person who wished to be heard in protest against the creation of said District and the construction of said improvements therein.


The Chairman then noted that the Board of County Commissioners will receive and consider further written protests against the creation of the Grand County Special Service Water District or the proposed improvements therein for fifteen (15) days following this meeting or until 5:00 p.m. on August 3, 1977.

The Chairman further noted that the Board of County Commissioners will meet in regular session at 10:00 a.m. on August 15, 1977, at its regular meeting place for the purpose of reviewing all written protests filed, and determining whether said written protests represent more than 50% of the qualified voters within the boundaries of the proposed Special Service District. In the event the protests represent less than 50% of the qualified voters, the Board of County Commissioners may establish the District in a manner consistent with the provisions of the Notice of Intention, or it may modify the District by, among other things, reducing the area within the boundaries of the Service District and/or limiting the services as proposed.

After the conduct of other business not pertinent to the above, the motion was made, seconded, and carried for the meeting to be adjourned.
