IN THE MATTER OF THE ORGANIZATION :
OF THE GRAND COUNTY WATER CONSERVANCY :
DISTRICT, PURSUANT TO TITLE 73, CHAPTER 9, :
UTAH CODE ANNOTATED, 1953, AS AMENDED. Civil No. 3158

P E T I T I O N

The undersigned Petitioners respectfully represent and show to the Court:

1. That they are desirous of organizing, establishing, and incorporating a Water Conservancy District to include all of Grand County, State of Utah.
2. That all of Grand County is within the jurisdiction of the above named Court.
3. That the proposed name of said District shall be the 'Grand County Water Conservancy District.'
4. That the undersigned are not fewer than 20% of the Owners of the land within Grand County, but not embraced within the limits of any incorporated city or town and also not fewer than 5% or 100, whichever is the lessor of the owners of land embraced within the limits of each incorporated city or town situated in the proposed district.
5. That opposite the name of each of the signers hereto, is listed the land owned by such signer and the land in each ownership, together with the improvements thereon, have an assessed value of not less than \$300.00, and that the assessed valuation of all irrigated land within said proposed district is in excess of \$50,000.00.
6. That the property within the proposed district will be benefitted by the accomplishment of the purposes enumerated in Section 3, Chapter 9, Title 73, Utah Code Annotated, 1953, to-wit:

For conserving, developing, and stabilizing supplies of water for domestic, irrigation, power, manufacturing, and other beneficial uses as contemplated in the said Water Conservancy Act.
7. That it is proposed to organize, establish and incorporate said district for the purpose of conserving, developing, and stabilizing supplies

of water for domestic, irrigation, power, manufacturing, municipal, recreational and other beneficial uses; for the purpose of constructing drainage works and all other purposes authorized by law; with the power to contract with the United States of America, the Secretary of Interior thereof, or any other officer or agency of the United States of America, with the State of Utah or any officer or agency of the State of Utah, as may be authorized by law; and with power to contract with the United States of America, with the State of Utah or any officer or agency of the State of Utah, as may be authorized by law; and with power to contract with the United States under any acts of Congress that may hereafter be enacted relating to any of the purposes for which said District is organized, established, and incorporated; and with power to contract with the State of Utah under any act of its Legislature that may hereafter be enacted, relating to any of the purposes for which said District is organized, established, and incorporated.

8. The divisions of the District are hereby designated as follows, and the number of Directors in each division is set opposite the description of each division:

| Division Number One: All incorporated areas of the City of Moab. | <u>2</u> |
| Division Number Two: Beginning at the intersection of the West Range line of Range 21 East and the Grand-San Juan County line, thence North along Range line to the point of intersection with the North Township line of Township 25 South, thence East along the Township line to the point of intersection with the East boundary of Range 22 East, thence South along the Range line to the point of intersection of the Grand-San Juan County line, thence West along County line to the point of beginning. | <u>1</u> |
| Division Number Three: Beginning at the intersection of the West Range line of Range 23 East, and the Grand-San Juan County line, thence North along the Range line to the Grand-Uintah county line, thence Easterly along the County line to the Utah-Colorado State line, thence South along the State line to the point of intersection of the Grand-San Juan County line, thence West along County line to point of beginning. | <u>1</u> |

Division Number Four: Beginning at the intersection of the East boundary of Range 20 East, and the Grand-San Juan County line, thence North along the Range line to the point of intersection with the North boundary of Township 25 South, thence East along the Township line to the point of intersection of the East Boundary of Range 22 East, thence North along the Range line to the point of intersection of the Grand-Uintah County line, thence West along the County line to the point of intersection of the Grand-Emery County line, thence Southerly along the County line to the point of intersection of the Grand-San Juan County line, thence East along the County line to point of beginning

9. Exhibit "A" is a Map of the proposed District showing the divisions described in Paragraph Eight above.


WHEREFORE, Petitioners pray:

(1) That by Order of the Court, the time and place of hearing of this Petition be fixed, and that notice thereof be given in accordance with law;

(2) That at said hearing, the Court make Findings of Fact and a Decree organizing, establishing, and incorporating the Grand County Water Conservancy District, with all rights, privileges, and powers prescribed by law;

(3) That the Court, after said Decree incorporating said District has been entered, appoint a Board of Directors in said District in accordance with law;

(4) For such other and further orders and decrees as may be proper in the premises.
